Limited Lifetime Warranty



Nebraska Plastics, Inc. guarantees that, for as long as you own the product, Nebraska Plastic's aluminum fence and railing products will be free from defects in workmanship and product materials. Nebraska Plastics, Inc. also guarantees that the baked on powder

coated finishes of all Nebraska Plastic's products will be free from cracking, peeling, chipping, blistering, rusting or crazing during the same time period. Notwithstanding the foregoing, in the case of an entity other than a natural person, the length of this Warranty shall not exceed twenty (20) years from the date of purchase. To be eligible for this Warranty, you must register by submitting this form and a copy of the proof of purchase to Nebraska Plastics within thirty (30) days of purchase to the address below. Failure to properly register will limit the terms of this warranty to three (3) years from the date of purchase. Proof of purchase is required for all warranty claims.

This warranty shall not apply and Nebraska Plastics Inc. shall not be responsible for the guaranteed performance or appearance of the product should the product be improperly installed. Neither does this warranty apply where failure or damage is due to abuse, misuse, vandalism, extreme environmental conditions or acts of God.

Should the product fail in accordance with any of the above conditions, the manufacturer, Nebraska Plastics, Inc., will, at its sole discretion, replace or repair the defective product or refund that portion of the purchase price covering the defective product. Notice of such failure shall be sent to the manufacturer in writing, along with photographs documenting the alleged defect, and shall specify the nature of the defect and when it was first observed.

Nebraska Plastics, Inc. reserves the right to request the return of the product, transportation charges prepaid, for the purpose of inspecting the material to determine the validity of the claim. Any replacement will be made from the factory and only for materials which have been returned to the factory in Hamden, CT, transportation prepaid. Materials must not be returned to the factory without prior authorization from Nebraska Plastics, Inc.. Nebraska Plastic's liability hereunder is discharged upon delivery of replacement materials to site. Nebraska Plastics, Inc. will not be responsible for any costs associated with removal or reinstallation of the product.

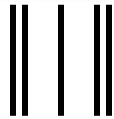

Code of Ethics

Each member company pledges:

1. To properly and effectively serve the needs of the ultimate user or consumer of the company's products or services;
2. To provide a professional, competitive and successful program that will establish and maintain the integrity of the fence industry;
3. To advertise or communicate to any person or company, by conversation, correspondence, newspapers, magazines, radio, television or any other means of communication:
 - a. Factual information only concerned with the growth of the company or its number of operating outlets at the time of communication;
 - b. True and proper representation of all policies, products and any other important information which has influence on the consumer;
 - c. Ethical consumer advertising, to avoid any misleading claims such as, but not limited to, false comparisons, untrue, unproven or exaggerated statements, trick photography or omission of pertinent facts; and
 - d. Indicate to the purchaser in published price lists, catalogs and mailings, that differences in gauges, weights, sizes, grades, etc., do exist in both steel and wood fences;
4. That all products furnished and sold to consumers through, by or upon the recommendation of the company, shall be represented and manufactured with ingredients or materials of acceptable standards approved by the applicable trade, profession or industry;
5. That it shall completely avoid, by demonstration and action, and shall encourage its personnel to avoid illegal practices of any sort;
6. That it shall respect all contracts, pay all obligations, maintain a good credit rating, and in other respects follow the highest standards of business conduct;
7. That it shall not, in any way, copy or represent the trademark or other distinguishing marks of other companies with intent to mislead the public; and
